Please note that submission of the 2007 Stallholder Application form does not guarantee a booking. Stall sites are limited, so we urge stallholders to submit application forms as soon as possible. All applicants will be notified by post on the status of their application in due course.

Terms & Conditions

- All stallholders must hold a current Public Liability Insurance cover of a minimum \$5million. It is the responsibility of the Stallholder to arrange Public Liability cover to insure against any claim that may be made due to their activities at the 2007 Bundeena Maianbar Art of Living Festival. Stallholders without appropriate coverage will not be able to operate.
- Food stallholders must comply with all requirements as outlined below in regards to completing the food notification form and complying with Sutherland Shire Council's Temporary Food Premises Code. Food stallholders who do not meet the outlined requirements or comply with necessary codes will be asked to leave the festival.
- All applications must be received no later than Friday 16th February 2007.

Terms & Conditions (continued)

- Stallholders must conduct their business within their specified site which is to be secured safely and reasonably presented i.e. goods or products displayed on the ground are not acceptable.
- No movement of vehicles on-site during set-up and dismantle is permitted without permission of the festival organisers. Vehicles must be moved immediately if requested by festival organisers.
- Stallholders are not permitted to sell any of the following banned items: Weapons of any kind, clothing or products with explicit or illicit material, alcohol and cigarettes.
- Festival organisers reserve the right to order the removal of any item from a stall.
- Stallholders are expected to clean and vacate their site by 6:00pm.
- In the event of unfavourable or extreme weather conditions, organisers may cancel the festival and no refund will be given.
- If any stallholders fail to comply with festival organiser instructions, stallholders will be removed from the festival.

Food Stallholder Requirements

In addition to the above stated Application requirements, food stallholders must also complete the form on **page 4** of the application form to detail food activity.

Food stallholders must also ensure they have read and comply with the Sutherland Shire Council's Temporary Food Premises Code. This code can be downloaded from the festivals website www.artofliving.com.au
